HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

In Person for Agenda Items and Non-Agenda Public Comment: Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

Via Virtual Platform for Agenda Items and Non-Agenda Public Comment: When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by

dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item.

When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first.

Those participating virtually may NOT cede time to others participating in person or virtually.

HOW TO PROVIDE WRITTEN COMMENTS:

For Agenda Items and Non-Agenda Public Comment: Submit using the [webform](#), indicating the comment type and item number (if relevant). Comments must be submitted the business day prior to the meeting to be distributed to the Hearing Officer and posted online with the meeting materials. All webform comments are limited to 200 words but may include attachments. Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. Please go to the Hearing Officer [website](#) for further instructions.

Written Materials: Instead of submitting materials as an attachment to the [webform](#), you may submit via U.S. Mail to the Hearing Officer at 1222 First Avenue, MS 501 San Diego, CA 92101. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

Please Note: Documents related to the Hearing Officer meeting agenda items which are distributed to the Hearing Officer prior to the meeting are available for public review at the Development Services Department Building, 1222 First Avenue, 1st Floor, San Diego, CA. 92101.

Late-Arriving Materials:

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 1222 First Avenue, 3rd Floor, San Diego, CA. 92101. This relates to those documents received after the agenda is publicly noticed and during the 72 hours prior to the start of the meeting.

Site Development Permit for the remodel of an existing four-story 3,457 square-foot residence and construction of a 1,779-square-foot addition, new exterior decks, a new pool, and a new 1,126-square-foot Accessory Dwelling Unit at the basement level of the existing structure at 2845 Union Street. The 0.42-acre site is in the Residential Multiple Unit (RM-2-5) and Open Space Residential (OR-1-1) Zones, Federal Aviation Administration Part 77 Noticing Area for the San Diego International Airport (Lindbergh and North Island), Airport Influence Area (Review Area 1), Airport Approach Overlay Zone, and contains Environmentally Sensitive Lands (Steep Hillsides) within the Uptown Community Plan area. ITEM 2: DUDUM RESIDENCE – PROJECT NO. 1081479**Staff:** Christian Hoppe**City Council District:****Plan Area:** La Jolla

Coastal Development Permit and Site Development Permit for the demolition of an existing single-dwelling unit located at 5270 Chelsea Street and construct a new 6,562 square-foot, two-story single-dwelling unit with a three-car garage, detached 607 square-foot accessory dwelling unit, pool, deck, and outdoor BBQ. The 0.29-acre site is located in the RS-1-7 Zone, Coastal Overlay Zone (Appealable Area), Sensitive Coastal Overlay Zone, Coastal Height Limitation Zone, Parking Impact Overlay Zone: (Coastal), First Public Roadway, Transit Area Overlay Zone, and Transit Priority Area within the La Jolla Community Plan area. This project was determined to be categorically exempt pursuant to Section 15301 (Existing Facilities) and 15303 (New Construction or Conversion of Small Structures) of the California Environmental Quality Act.
