There are no standing subcommittees.

Ad Hoc Committees on Fire Safety, Chabad Educational Complex, Carroll Canyon Center, the Scripps Ranch Technology Park, were continued.

An Ad Hoc committee on the Redevelopment of the Renzulli Property, joint with the Miramar Ranch North Planning Council, established in February 2019, was continued.

Ad Hoc Committees that were established for Public Facility Financing Plan Review, Hendrix Park Design, the Redevelopment of the Alliant University Property, and Capital Improvement Program review, were discontinued.

Section II. **Administrative Issues**

Twelve meetings were held in April, May, June, July, August, September, October, November, and December of 2021, and in January, February and March of 2022. Meeting descriptions are given in Section VIII below.

At the March 2022 election, 2 new members, and 7 current members who were not term-limited were elected. Two incumbents who were term-limited left the Group, See section VII below for details.

Section III. **Community Plan Preparation and Implementation**

<u>1. Renzulli Estate.</u> The Phair Company is purchasing the "Renzulli Estate"—a 40-Acre parcel in the gap between the two portions of Cypress Canyon Road—, and proposes construction of 90 to 100 single-family homes. The property includes steep hillsides, canyons, and ephemeral wetlands, so it would be difficult to build more homes. On May 2, 2019, the SRPG voted unanimously to recommend initiation of a Community Plan Amendment for rezoning and permitting for the project. The Planning

Commission voted on February 13, 2020, to initiate the CPA. The Notice of Preparation for the Environmental Impact Report was distributed in April 2022.

Section IV. Special Projects

- 1. The Ad Hoc Subcommittee on the Technology Park has been working on a plan to expand the parking lot at the Scripps Ranch Library. In September 2020, the Public Works Department presented updated development plans. We continue to monitor this development. See V.3.L below.
- 2. At our October 3, 2019 Meeting, the SRPG reluctantly approved an update to the Public Facilities Financing Plan for Scripps Miramar Ranch. Ad Hoc Subcommittee meetings were held throughout August 2019. The SRPG disagrees with the Planning Department's characterization of the PFFP, and with any proposals to centralize or redirect any FBA funds or accounts.
- 3. In November, 2021, the SRPG approved budgets for the Rancho Encantada and Scripps Miramar Ranch Maintenance Assessment Districts.

Section V. Summary of Project Reviews

- May 2021 Action: PTS#688250 Digital-Scripps Ranch NDP. Murphy Development Corp. and Alexandria Real Estate Equities Inc. are applying for a Neighborhood Development Permit for pharmaceutical manufacture in the Technology Park. This action will remove the prohibition on manufacture of "drugs" included in the 1985 Planned Industrial Development permit, bring permitted uses in line with all other prime industrial areas in San Diego, and allow our Technology Park to participate in regional innovation in biotechnology. Motion 1st/2nd: Ringel/Marshall -Without objection recommend approval of proposed amendment.
- November 2021 Action: PN 690573; Renewal of Neighborhood Use Permit for AT&T Wireless Communication Facility at 10455 Pomerado Road. (T. Carmichael, MD7 / AT&T) Expired NUP in 2020. Requesting continued use of site. No new proposed work. Currently there are: 4 antennae's plus 6 equipment cabinets on the ground level. Motion/2nd: Dennis/Stewart Unanimously Passed 15-0-0
- 3. Summary of Development and Construction Projects in Scripps Ranch through April 2022

A. Fairbrook Park

Fairbrook Road and Rue Fontenay.

This park had been planned since 2009. Design was done in 2017. Due to poor or no coordination between the City's Parks, Development Services, Public Works, and Stormwater departments and the local community, and concession to the developer of nearby homes, the park lost about 3 acres of land from the original plan. Construction was again delayed until it finally began in Fall 2020. Completion is now expected in Summer 2022.

B. Proposed Park at Hendrix Pond

The Parks and Recreation department met with the community on March 14, 2019 at 7:00pm in the Library. Since the park was initially proposed in 2016 some residents have requested that a dog park area be included, but other residents are strongly opposed. The city will work with the community on design. Subsequent meetings were held among the Parks Department and the Community, after which the Parks Department erroneously removed further work on the park from our Capital Improvement Program. No funds are currently programmed for construction.

C. Renzulli Property

The Phair Company is continuing development of the Renzulli estates. The property is located between the two segments of Cypress Canyon Road. The initial plan is for about 100 homes on the 57-acre property. These would include starter homes at around 2100 sq. ft. priced at \$800,000 to \$850,000; "Move up" homes at around 2475 sq. ft. for \$900,000 to \$1M, and "multigenerational" homes with a second master suite downstairs for \$1M+.

G. The Glen at Scripps Ranch

Pomerado Road at Chabad Center Driveway

450 units: villas, apartments, and continuing care residences for senior retirees. Construction was completed in 2020, and the facility is now occupied. The project also includes Ridgeview health center which completed in 2021.

H. Ascent at Campus of Life Apartments

Pomerado Road at Chabad Center Driveway

In 2009 the City approved construction of 280 new housing units at the Chabad Campus for student and faculty housing for a K-12 school and Yeshiva. When the first 84 units were completed last year, they were advertised to the public as luxury apartments. The City Attorney determined that the apartments conform to the Conditional Use Permit for "educational" use of the land since the leases require residents to attend lifestyle classes such as Yoga and Gardening.

I. Carroll Canyon Mixed-Use Apartments.

9850 Carroll Canyon Road at I-15

This is a 260-multiple-unit residential mixed-use development with 10,700 square feet of commercial space on a 9.28-acre site. The project will also include a new traffic signal and road improvements on Carroll Canyon Rd. Work began in June 2020 and is ongoing through 2022

J. Pure Water Connection to Miramar Reservoir.

Miramar Road up to Miramar Lake.

The San Diego Water Department will install a large underground pipeline from the Eastgate treatment plant, along Miramar Road, then under I-15 and up to Miramar Lake through the business park. Construction is scheduled for 2019 through 2023. The project will close 80 parking spaces at Miramar Lake during 2019 and 2020, but will provide about 100 new spaces. The boat ramp and concession area will be closed during construction.

K. Miramar Clearwells

L. Scripps Ranch Library Parking Lot.

10310 Scripps Lake Drive.

The SRCA and SRPG have been advocating for a parking lot expansion for the past several years. The project was in design through 2021. This project would yield additional parking spaces, 5 ADA parking spaces and 5 spaces for EV Charging Stations. In Phase One 53 parking spaces will be available, including ADA parking spaces. M. Scripps Ranch Technology Park Hoyt Park Drive, Meanley Drive, Scripps Ranch Blvd.

See Item V.1 above. The Murphy Development Corporation purchased 12 parcels in the Business Park. They will build industrial buildings. The SRPG already approved a 325,000 sq. ft. building at Hoyt Park Drive and Scripps Ranch Blvd which began construction in 2021. http://scrippsranchtechpark.com

Section VI. Planning Group Objectives

The Planning Group will continue to work on improving communication with all residents, including Rancho Encantada, so that they are more fully involved with community interests.

In accordance with CityCouncil Policy 600-24, the Planning Group will continue to address its expanded responsibilities for advising the City and other agencies on land use, mobility and transportation, urban design, public facilities & services, economic prosperity, conservation, noise, historic preservation, and infrastructure.

Section VII. Roster Summary

Ten member seats were available for election or re-election in March 2022. New members Reg Kobzi and Shauna Lindsay were elected. The following members were re-elected: Gordon Boerner, Dennis Engler, Matt Johnson, Emma Lefkowitz, John Lyons, Gwen Bandt, and Marc Sorensen. Ron Kelley resigned effective in March, but too late for the vacancy to be included in our election. It will be filled by appointment at a future meeting.

Section VIII. Meeting Summaries

The following Summaries were printed in the *Scripps Ranch Civic Association Newsletter* at the beginning of each month. Over 12000 copies of the *Newsletter* are distributed free to homes in the Scripps Ranch and Rancho Encantada areas each month.

April 2021 Election Results: Our election of members was held on March 4. The following people were elected this year: Julie Ellis, Tamar Silverstein, Stuart Gross, Christopher Keane, Marty Lorenzo, Victoria LaBruzzo, Jenny Marshall, Robert Petering, Don Ringel, Marvin Miles, Marc Sorensen.

An Opening on the Planning Group:

We have an upcoming opening to fill a remaining year term on our Planning Group due to a member resignation. If you are interested in being appointed to this vacancy, please contact me, and plan to attend meetings of the group. Any resident, property owner, or person associated with a business in Scripps Ranch and Stonebridge is eligible.

Pure Water Status Update:

The Water Department staff gave us an update on the Pure Water program. The project's ultimate goals have been expanded: It is expected to provide up to half the water for our area after completion of phase 1 in about 2025, and for the whole city when complete in 2035. Phase 1 of the project consists of construction and/or improvements to the Morena Pump Station, a pipeline to the North City Water Reclamation Plant, the North City Pure Water Facility, the Metro Biosolids Center, a Pipeline from the Pure Water Facility to Lake Miramar, and the Miramar Water Treatment Plant. When complete, this will produce about 30,000,000 gallons of purified water per day into Miramar Lake, where it will blend with imported and local water supplies.

Construction of the pipeline between the North City Pure Water Facility and Miramar Lake is schedule to begin in the Summer of this year – 2021. The pipeline will be installed mostly along Miramar Road. It will pass under I-15 near Businesspark Avenue, and continue along Carroll Canyon Road and Hoyt Park Drive, to a De-chlorination Station on Meanley Drive, then under the technology park and Scripps Lake Drive to the Lake. You can expect construction at night from 9pm to 5am. Access for residents, businesses, and emergency vehicles will be maintained. There may be brief scheduled water outages.

There will be substantial construction at Miramar Lake from 7:00am to 4:30pm. The lake will be closed to boating during construction, but surrounding trails and the loop around the lake will remain open. On-shore fishing will be permitted around most of the lake. Even during construction, 25 additional parking spaces will be provided at the Lake, and after completion, we will have a net gain of about 60 parking spaces.

May 2021

The Planning Group held its regular meeting on April 1. We re-elected our current officers: Chair, Wally Wulfeck; Vice Chair, Sandy Wetzel-Smith; Secretary: Tamar Silverstein. Another Vice Chair will be elected at our May 6 meeting. Renzulli Estates:

The Phair Company has continued to hold meetings in conjunction with the Civic Association. Mr. Phair recently announced that, at the request of neighbors, they have redesigned the location of the affordable housing units included in the project. The units will no longer be adjacent to Mundial Street, but will instead be in the upper part of the project near Cypress Canyon Road. The project is in the submittal process: the planning group will provide its recommendation when the environmental analysis and submittals are complete. Personally, I would like to commend the Phair company for their willingness to work with the community.

Change in Ambulance Services Contractor:

The City's contract for emergency services with American Medical Response (AMR) expires on June 30, 2022. AMR has provided ambulance services in San Diego for the last 23 years. The City has conducted a competition for the contract since 2019, and announced in December 2019 that it has selected Falck USA which currently provides services in parts of Alameda, Los Angeles, and Orange counties, and in other states. AMR subsequently protested the selection, but over-the-summer negotiations with Falck resulted in a five-year contract award in December 2020 subject to City Council approval. The council's Public Services and Livable Neighborhoods committee voted in February to send the contract to the full City Council without a recommendation. The Council hearing was held April 13, and the Falck contract was approved unanimously.

Library Master Plan:

The City of San Diego Library System is developing a new Master Plan for our libraries. An on-line survey has been conducted during February through April. The next step will be to conduct 10 to 15 focus groups during the Spring. As the plan is developed there will be presentations to key community groups, the Library Commission, City Council, key stakeholders. The Library and the Library Foundation will be collecting feedback from the public.

San Diego Development Services Department Update:

The Development Services Department (DSD) is working hard to transition from paper to electronic services. During 2020, DSD issued over 52,000 permits and completed over 139,000 permit inspections. In the midst of the pandemic, DSD has initiated:

 \checkmark Digital Online Permitting Launched on May 4, 2020 – provides customers with 24/7 access

 \checkmark Virtual Inspections – for 26 permit inspection types - done via tablet or smart phone

✓ Virtual Counter meetings – replacing in person Counter services

 \checkmark Virtual Public Hearings – Planning Commission, Historic Resources Board, Hearing officer and the Technical Advisory

Committee

✓ Electronic Noticing for All Projects – ensures stakeholders receive timely notifications New online permitting is provided for: demolition, fire suppression systems, mechanical, electrical, and plumbing, residential solar, signs and traffic control. In 2121, most use, building, engineering, and other discretionary permits will be supported. In addition, virtual counter services are available for planning and zoning, traffic control, historic properties, and records review. The next phase will include plan review service for submitted projects.

DSD has transitioned to Electronic Public Notices for most projects. You can sign up for them at www.sandiego.gov/DSD -- select "News and Updates". You can select the types of

notices you would like to receive.

Meetings:

June 2021

The Planning Group held its regular meeting on May 6. We appointed Steve Wilson, a new member, to fill a vacant one-year term. We elected Stuart Gross as our second Vice Chair.

Technology Park:

Murphy Development has been in negotiations with Alexandria Real Estate Equities to develop several lots in the Technology Park for biotechnology. Alexandria is one of the largest nation-wide real estate companies providing life science facilities for biotechnology companies. At our meeting, the group voted unanimously to recommend approval of a Neighborhood Development Permit for manufacture of drugs and pharmaceuticals. These are permitted in all IP-2-1 zones in the City. As one of the fastest growing industries in the City, we welcome the expansion of biotechnology companies into Scripps Ranch.

Redistricting:

Commissioner Alan Nevin, chair of the San Diego city redistricting commission, and Lora Fleming, Chief of Staff, gave an overview of the group's activities to ensure that this redistricting process includes a great deal of public input, and engages residents early. The City Charter requires the creation of a Redistricting Commission at the beginning of each decade, after the U.S. Census, to adopt plans which specify the boundaries of districts for the City Council. This process is independent of the City Council and Mayor's Office.

Districts are made up of contiguous territory and made as equal in population as shown by the Census reports, and as geographically compact as possible. It also requires that the districts shall, as far as possible, be bounded by natural boundaries, street lines, and/or City boundary lines.

The Charter requires that the districts be drawn to provide fair and effective representation for all citizens of the City, including racial, ethnic, and language minorities. Additionally, to the extent possible, they preserve identifiable communities of interest. The redrawing of district boundaries is designed to ensure local legislatures are representative of the City's diverse population.

Speed Limits:

The Traffic department has conducted traffic speed surveys along Pomerado Road, Spring Canyon Road, and other streets in accordance with state law. The survey shows that the speed limit on Pomerado Road southwest-bound between Semillon Blvd. and Fairbrook Rd. should be raised to 50 mph. The planning group recommended that the posted speed remain at 45mph, even though this limit will not be enforceable by radar.

At our June 3 meeting, another proposal to raise speed limits on Spring Canyon between Pomerado Road and Semillon Blvd. to 50mph in both directions will be considered.

We continue to get complaints on excessive speed throughout Scripps Ranch. We urge our neighbors to slow down and obey the speed limits, particularly the 25mph speed limit in residential zones.

Fire Insurance:

Sandy Wetzel-Smith, Vice Chair of the planning group and a member of the Fire Safe Council, and Lance Witmondt, Chief of Staff for Assemblymember Brian Maienschein, gave an update on their work with the Insurance Commissioner to address nonrenewal by fire insurance companies in our area. They are investigating ways for the state to help via regulation, and home-hardening for fire safety.

July 2021

The Planning Group held its regular meeting on June 3.

Speed Limits:

The Traffic department proposed raising speed limits on Spring Canyon between Pomerado Road and Semillon Blvd. to 50mph in both directions. The Planning Group voted to request that the posted speed limit remain at 45 mph in both directions. We continue to get complaints on excessive speed throughout Scripps Ranch. We urge our neighbors to slow down and obey the speed limits, particularly the 25mph speed limit in residential zones.

Parking Policy:

The city is proposing a code amendment to eliminate minimum development parking requirements for most non-residential land uses within transit priority areas, and for neighborhood serving commercial land uses citywide. This follows the elimination two years ago of minimum development parking requirements for multi-family housing land uses within transit priority areas. These are aimed at reducing dependency on single occupancy vehicle use and greenhouse gas emissions and supporting investments in transit and active transportation. The Planning Group voted to oppose this policy because there are no provisions for electric vehicles which will do much more to reduce greenhouse gas, and because it penalizes residents who must drive because of the lack of transit. Councilmember Marni von Wilpert's committee on Active Transportation and Infrastructure heard the proposal on June 16, and it will go to the full City Council in July.

Capital Improvement Projects

Every two years, the City of San Diego updates its plan for capital improvements. Capital projects are those that involve construction or replacement of durable structures. They do not include maintenance or ongoing operation of city facilities.

In 2017 Scripps Ranch submitted eight projects. Two of these are now underway. The first is the parking lot expansion at the Scripps Ranch Library – it is fully funded in the city's budget. The second is parking expansion at Lake Miramar, which is being done as part of the Pure Water pipeline project.

The following were our submissions for FY21-25, which we will probably re-submit:

Fire Station 37A Annex: It consists of a smaller station with a brush truck, ambulance, and space for a police and RSVP office. It would tentatively be located at Avenida Magnifica and Pomerado Road, and is meant to serve the Stonebridge and southern Scripps Ranch communities. Although the City found no substandard delays in emergency response in their 2017 report, our community is adding several thousand new residences since that data was collected. In addition, because we are in an extremely high fire hazard severity zone, a substantial response is essential as quickly as possible when a possible wildfire is reported.

Our second priority is to reconstruct Scripps Ranch Court and construct a pedestrian bridge to Scripps Ranch High School. The school district is interested in the bridge for its SRHS Master Plan, and the road reconstruction is necessary to prevent further erosion and damage.

The third priority is to provide reclaimed water for Hendrix Pond. Evans Pond already has this. There is a pipe stub for reclaimed water on Aviary Drive, which we hope can be extended to provide less expensive water.

We would still like the reclaimed water line at Pomerado Road and Willow Creek Road extended east to Avenida Magnifica and Fairbrook Road. The project was evaluated in 2018 in conjunction with developments south of Pomerado Road, but was found to be infeasible because of hydraulic and pressure limits for the existing pipeline. This means that we will have to request some sort of pump station. The City is unlikely to support this because they are committing most of our resources to the Pure Water program.

Bills in the California Legislature:

Several Bills before the California Legislature will greatly affect housing policy, including in Scripps Ranch. Senate Bills 6, 7, 8, 9, 10, 55, 290, 477 and 478 have passed the Senate and are now awaiting action in the Assembly. Please let Assemblymember Brian Maienschein know your views.

Assembly Bills 6, 215, 989, 1322, 1398, and 1401 passed the Assembly and are now in the Senate. Please send Senator Brian Jones your opinions.

August 2021

The Planning Group held its regular meeting via Zoom on July 1.

Parks Master Plan:

The City's proposed Parks Master Plan is scheduled for City Council hearing on August 3. The new draft PMP replaces the current "2.8 acres per thousand people" standard with a

complicated scoring system that award points for land (7 points per acre) and amenities such as restrooms (21 points), shade covers (7 points), interpretive educational or cultural signs (7 points), food concessions (7 points), . The new park goal would be 100 points per thousand people. It is still unclear as to whether the points system would be used for park design, community planning, and/or calculation of developer requirements and fees.

The new PMP also replaces the current development impact fee system, which applies locally within communities, with a Citywide impact fee system. It would collect money from new developments anywhere in the city, and require that a large percentage then be spent on underserved and park-deficient communities. The purpose of this system is to correct the historical imbalance in park access and quality between newer communities that have collected fees and have developer-built parks, and older communities planned before park acquisition and development were required. While the parks proposal has been significantly improved over the past several months, the planning group has consistently voted in the past to oppose the new PMP for several reasons: the points system is too complicated and undervalues park acreage; the citywide fee would not collect enough money to address park deficiencies; the Planning Department has systematically ignored Community Planning Groups and Community Recreation Groups and curtailed public comment. Moreover, the Planning Department has been continually revising the proposal, and at this point we don't know exactly what proposal details will be included in the City Council hearing on August 3.

Capital Improvement Projects

Every two years, the City of San Diego updates its plan for capital improvements. Capital projects are those that involve construction or replacement of durable structures. They do not include maintenance or ongoing operation of city facilities.

In 2019 Scripps Ranch submitted eleven projects, plus one in Rancho Encantada. Several of these are now underway. The parking lot expansion at the Scripps Ranch Library is fully funded in the city's budget. Parking expansion at Lake Miramar is being done as part of the Pure Water pipeline project. We also requested improvements at Jerabek Park, which were funded by a state grant by Assemblymember Brian Maienschein. Fairbrook Park is under construction for completion in 2022. We deleted our request for raised medians on Stonebridge Parkway for fire evacuation safety.

We also included requests for reclaimed water at Hendrix Pond, and improvements to the Hendrix Pond / Aviary Park area. However, the Parks and Recreation Department erroneously concluded that those were no longer desired by the community, and deleted them. We will resubmit.

The following are our submissions for FY23-27:

Fire Station 37A Annex: An additional station for fire and police response.

Reclaimed water for Hendrix Pond. Evans Pond already has this. There is a pipe stub for reclaimed water on Aviary Drive, which we hope can be extended to provide less expensive water.

Park improvements in the Aviary Park / Hendrix Pond area.

We added a request for traffic calming on Cypress Canyon Park Drive as the Renzulli development goes forward. We continue to request additions and improvements to Cypress Canyon Park.

We continue to request an extension of the reclaimed water line along Pomerado Road from Willow Creek Road east to Avenida Magnifica and Fairbrook Road. This will apparently require some sort of pump station and/or tank. Unfortunately, the City is unlikely to support this because they are committing most of our resources to the Pure Water program.

We still would like the City to reconstruct Scripps Ranch Court and construct a pedestrian bridge to Scripps Ranch High School.

Bills in the California Legislature:

Assembly Constitutional Amendment 7 (ACA 7) would allow voters to decide whether land use and zoning decisions should be made at the local level. Current state practice is for the legislature to declare that an issue is of statewide interest and override local ordinances. This measure, if it makes it to the ballot and then passes, would amend the state constitution to declare that local municipal decisions would take precedence over state mandates.

Senate Bill 7 exempts certain large development projects from some provisions of the California Environmental Quality Act. It was passed by both houses of the legislature and signed by the governor on May 20, 2021.

Other Bills before the California Legislature will greatly affect housing policy, including in Scripps Ranch. Senate Bills 6, 8, 9, 10, 55, 290, 477 and 478 have passed the Senate and are now awaiting action in the Assembly. Assembly Bills 6, 215, 989, 1398, and 1401 passed the Assembly and are now in the Senate. Please let Senator Brian Jones and Assemblymember Brian Maienschein know your views. September 2021

The Planning Group held its regular meeting via Zoom on August 5.

Parks Master Plan:

The City's proposed Parks Master Plan was passed by the City Council on August 3. The new PMP includes a City-wide development impact fee (DIF) that requires new development to pay into a fund that may be used anywhere in the City for parks, rather than only in the immediate area in which fees are collected. The new PMP replaces the current "2.8 acres per thousand

people" standard with a complicated scoring system that awards points for land and amenities such as restrooms, shade covers, interpretive educational or cultural signs, or food concessions. Please see the City's website at: https://www.sandiego.gov/parks-for-all-of-us.

Homes For All Of Us:

Renzulli Development:

The Phair Company has proposed development of about 100 new homes on the former Renzulli property, between the two existing segments of Cypress Canyon Road. The developer had originally proposed that the two segments become cul-de-sacs, with an emergency fire lane between them. However, at this time, the City is apparently requiring that the two segments be connected to form a two-lane residential collector street. This would provide complete access and improve fire evacuation. Plans for the project are still under development. The next steps will be a Draft Environmental Impact Report later in the fall, with a 45-day public comment period. When the EIR is finalized, the project would then go to the Planning Commission, followed by a City Council approval hearing. Both these hearings will include public comment as well. Please note that nothing has been approved at this point.

Many residents to the west of the development are opposed to connecting Cypress Canyon Road, while residents to the north and east are opposed to the cul-de-sac plan. Both the planning group and the SRCA are working with the city and the developer on plans for traffic calming to mitigate development effects.

Bills in the California Legislature:

Assembly Constitutional Amendment 7 (ACA 7) would allow voters to decide whether land use and zoning decisions should be made at the local level. Current state practice is for the legislature to declare that an issue is of statewide interest and override local ordinances. At press time, other Bills before the California Legislature are still pending that will greatly affect housing policy in the City of San Diego, including in Scripps Ranch. Assembly Bills 6, 215, 989, 1398, and 1401 passed the Assembly and are now in the Senate. Also, Assembly Bills 339 and 361 are pending in the Senate which would extend exemptions from the Brown Act so that electronic meetings for most public groups to continue. Renzulli Development:

The Phair Company has proposed development of about 100 new homes on the former Renzulli property, between the two existing segments of Cypress Canyon Road. The developer had originally proposed that the two segments become cul-de-sacs, with an emergency fire lane between them but the City is requiring that the two segments be connected to form a two-lane residential collector street. The Phair Company has proposed a new site concept, that would indirectly connect the two segments. Please see the diagram.



This would provide complete access and improve fire evacuation. Plans for the project are still under development. The next steps will be a Draft Environmental Impact Report later in the

fall, with a 45-day public comment period. When the EIR is finalized, the project would then go to the Planning Commission, followed by a City Council approval hearing. Both these hearings will include public comment as well. Please note that nothing has been approved at this point.

Bills in the California Legislature:

Bills in the California Legislature:

The Governor signed into law 770 of the 836 bills that were passed by the legislature. These include:

- Making Ethnic Studies a high-school graduation requirement.
- Requiring mental health instruction in middle and high schools.
- Mandating gender-neutral toy sections in department stores.
- Prohibiting obstruction of vaccination clinics.
- Continuing a tax on your phone to support high-speed internet.
- Authorizing restaurants to sell cocktails to go.
- Prohibiting gas-powered leaf blowers and lawnmowers.
- Continuing provisions allowing electronic meetings.

The Governor vetoed bills that would have expanded financial aid, paid for sobriety, allowed cannabis advertising on highway billboards, decriminalized jaywalking, and permitted "rolling stops" for bicyclists.

Many Bills before the California Legislature were passed that greatly affect housing policy in the City of San Diego, including in Scripps Ranch. Senate Bills 9 and 10 allowing more

intensive development in existing residential neighborhoods, were passed by both houses and signed by the Governor.

Auxiliary Dwelling Units.

The City of San Diego has already adopted even more lenient requirements for ADUs than those adopted by the state. The planning group and the Community Planners Committee voted to recommend the City modify its ordinances to allow a maximum of four units per SB9, and to not adopt or rescind any provisions of SB10.

December 2021

The Planning Group held its regular meeting via Zoom on November 4.

Redistricting:

One of the most important but little understood political processes is underway right now. Every ten years, after the federal census, boundaries are redrawn for many elective offices. The City of San Diego's Redistricting Commission determines City Council districts. Ten years ago, we were successful in re-uniting Rancho Encantada with Scripps Ranch in District 5, but this year, at press time, this has been reversed. The current proposal is to split the area south of Pomerado Rd and Rancho Encantada into District 6. The commission published its "final provisional map" on November 13. There are additional hearings scheduled on December 1, 7, and 15, with the final map adopted on December 16. The County of San Diego's Independent Redistricting Commission is re-drawing county supervisorial districts. Several maps have been proposed which radically change district boundaries. Please see www.sandiegocounty.gov/content/sdc/redistricting.htm.

The State's California Citizens Redistricting Commission determines boundaries for districts for the Assembly, State Senate, Board of Equalization, and seats in the U.S. Congress. Please see: wedrawthelinesca.org.

All of these commissions are politically independent. Their final recommendations will be adopted in December and take effect in 2022, without review or approval of any other public officials, and will affect elections starting next year. District boundaries affect who runs for office and who is elected to represent us, as well as the policies and legislation that greatly influence our daily lives on matters such as climate, roads, taxes, housing, and the environment. We will publish a complete list of results in January. Meanwhile, please visit the webpages above for up-to-date information.



The City of San Diego's Redistricting Commission, which determines City Council districts, voted on November 13 to move the area south of Pomerado Road and all of Rancho Encantada into District 6 – Mira Mesa. The map and a report concerning population and racial demographics are available at:

This map was adopted after about 60 hours of public comment, most of it from citizens in other parts of our city, who advocated passionately for establishing racial empowerment districts, reuniting other parts of the City such as Clairemont, or for improving representation for UCSD students. At the November 13 meeting, written comments were submitted, but only one person from Scripps Ranch called in to the commission meeting, asking that Scripps Ranch, including Rancho Encantada, be kept whole in District 5.

Additional meetings are held to "tweak" the map, so there still might be a chance to affect the final decision. These are scheduled for December 1, 7, and 15, all at 5:30pm. The final map will be adopted on December 16.

If the map stays as is, then Scripps Ranch will be split into two different City Council districts. Possible consequences might include additional development south of Pomerado Road, since District 6 including University City is the fastest growing area of the City. However, it is possible that we will have influence in both Districts 5 and 6, increasing our presence at the City Council.

January 2022

The Planning Group held its regular meeting via Zoom on December 2.

Redistricting:

Last month the City Redistricting Commission cut into Scripps Ranch, moving some residents south of Pomerado Road and in Rancho Encantada into District 6 (Mira Mesa). As of press time this month, the commission is exploring cuts deeper into Scripps Ranch, tentatively moving residents in the Erma Rd. / Affinity Ct. area and areas along Scripps Ranch Blvd south through the Technology Park into District 6. Some maps under discussion cut farther east so that everything west of Scripps Ranch Blvd would move into District 6, but they return the area south of Pomerado to District 5.

The other Redistricting Commissions for the County, State, and the School District also came up with new district boundaries in December. Next month we'll explain the changes to our area, and the implications for upcoming elections.

Final maps for all these commissions were adopted in December, but too late for this issue. Next month we'll explain the redistricting actions, and how they will affect our area.

Maintenance Assessment Districts

The SRPG approved budgets for our MADs in Scripps Miramar Ranch and in Rancho Encantada at our December 2 meeting. The Miramar Ranch North Planning Committee adopted their 2023 budget in November.

The total MAD budget for Scripps is \$\$2,122,580.00. This includes supplies such as soil conditioners, recreation equipment repair parts, paint, electrical, plumbing, and janitorial items. It includes almost \$1.7M for services such as pond maintenance, pest control, court resurfacing,

parking lot maintenance, playground surfaces, landscaping, and tree trimming. About \$97K is provided for utilities—including almost \$94K for water for fields and ponds. Administration and management are included at about \$259K. This is paid for with an assessment of \$189.10 per lot, which is included on your property tax bill. In Scripps Miramar Ranch, we are consuming the reserve fund because the assessments are at the voter-approved maximum. The rate can only be raised by a vote of property owners, and we anticipate an election to raise it probably in 2023.

The Planning Group also approved a budget of \$173,847.00 for Rancho Encantada / Stonebridge Estates. This is used mostly for the city-owned Sycamore Canyon Park and other city-owned facilities. The assessment on your property tax remains at \$150 and no increase is anticipated. The maximum already approved is over \$421 per lot, so no vote will be necessary for quite a few years. The MAD is much smaller than for Scripps or Miramar Ranch North because most of common land in the area is owned and maintained by the Homeowners' Association.

The Planning Group also heard a plan for restoration in the Scripps Miramar Ranch MAD in the 2023 fiscal year. Work will be done for restorative thinning of dead and non-native vegetation in Hoyt Park East. Last year's work was in the area south of Pomerado Road between Avenida Magnifica and Fairbrook Road.

February 2022

The Planning Group held its regular meeting via Zoom on January 6, 2022.

Redistricting:

In December, new districts were drawn for City Council, the San Diego Unified School District, the County Board of Supervisors, the state Assembly, Senate, and Board of Equalization, and U.S. Congressional representatives. All the new districts will take effect in January 2023, with candidates running for election to these districts in primaries on June 7 and the general election on November 8, 2022.

San Diego City Council

The City Redistricting Commission moved residents in the Erma Rd. / Affinity Ct. area and all areas west of Scripps Ranch Blvd south to Pomerado Rd. into District 6. This includes the Willow Creek / Atrium / Appaloosa / Aviary neighborhoods and the Trader Joes and "old Vons" shopping centers. They also moved all of Rancho Encantada / Stonebridge into District 6.

District 5 will continue to be represented by Councilmember Marni von Wilpert. District 6 will elect a new council member to replace the retiring Chris Cate. Current candidates include: Tommy Hough, Kent Lee, Christina Carter Nichols, and Aleena Nawabi.

San Diego Unified:

Scripps Ranch was moved from District B, currently represented by Kevin Beiser, to District A, represented by Sabrina Basso. The next election will be in 2024.

San Diego County Supervisor:

Scripps Ranch was moved from Terra Lawson-Remer's District 3, into District 2 currently represented by Joel Anderson.

California State Assembly:

Scripps Ranch was moved out of Brian Maeinschein's District into District 75, currently represented by Marie Waldron (R) of Escondido. Mr. Maeinschein will run in District 77

California State Senate:

We are currently in Senator Brian Jones' District 38, but have been moved to the new District 40, currently represented by Senator Ben Hueso.

United States House of Representatives:

Scripps Ranch was moved from Rep. Scott Peters' 52nd District, to District 51. The current incumbent is Rep. Juan Vargas. Mr. Vargas is expected to run in the new 52nd district, while Mr. Peters will run in District 50. Sara Jacobs (currently representing District 53) and Barrett Holman Leak have announced their intentions to run in the new District 51.

All of these changes to districts at all levels of government will probably lead to serious confusion during the upcoming primary and then election seasons. At this point most voters have no idea of their assigned districts or indeed their current district. Many do not know who their current representatives are. The Planning Group and the SRCA will hold candidate forums in the Spring.

We have two new candidates for election to the SRPG: Reg Kobzi and Shauna Lindsay. Thank you, Reg and Shauna, for volunteering to serve your community.

The following people are candidates for reelection to two-year terms: Gordon Boerner, Dennis Engler, Emma Lefkowitz, John Lyons, Matt Johnson, Gwen Bandt, Marc Sorensen. Attack on Community Planning Groups:

CPGs are once again under attack from both the City's Planning Department and by industries and organizations that benefit from dense housing development. Council Member Joe LaCava (District 1) is proposing "reforms" which will reduce CPG involvement and inclusion in City governance. After over 50 years, the reform proposal essentially divorces the City from CPGs. The proposal actively deters long-time residents who are interested in their communities, but provides no incentive for supposedly under-represented volunteers to get engaged.

This whole "reform" is based on a part of the City Charter that requires advisory group members to be appointed by the mayor. Mr. LaCava proposes to avoid this by restructuring the City's relationship with the planning groups so they don't really count as "advisory". At a time when trust in government is at an all-time low, I believe the City should seek to strengthen its relationships with residents and communities, and include more citizen involvement.
